ICI 8.2 (Patch 5)

Icertis Contract Intelligence (ICI) 8.2 Patch 5 brings some bug fixes and updates.

Bugs fixed

The following bugs have been fixed in this patch (8.2.5.0):

CS0174285	1737476	* ICI didn't work when user tried to login as an administrator.
CS0170029	1732709	Attribute text was truncated in agreements and created readability issues.
CS0169410	1733192	* Fulfillments that were created after auto-releasing obligations based on the On Hold Expiry Date didn't have a team and other details.
CS0168925	1734989	When you tried to link a new association to a legacy contract, the lookup search filter wasn't applied.
CS0166520	1725091	Advanced search didn't work when the user pressed Enter after entering the text string. It worked only when user clicked Search .
CS0163879, CS0148996	1720817, 1693878	If the Business API endpoint was called using browser console, a CORS issue occurred.
CS0163493	1718028	* While creating an RFx, you could add the Company Representative and Contracts Adviser attributes and select the User data type. However, adding users for these attributes took a long time to load users, and sometimes users were not loaded.
CS0163336	1717714	Inheritance of attributes from contract request to agreement didn't work as expected.
CS0162233	1723383	When the language preference was set to a language other than English, duplicate attributes appeared in the Select Columns drawer.
CS0162225	1715724	* You couldn't upload documents to an agreement that was in Executed status and had an amendment to it.
CS0162218	1714176	(ETC time zone only) The dates recorded in Saved Searches and those in the widget which is accessible on the Home page weren't consistent for the ETC time zone.

CS0162181	1716775	In ICI, at times the downloaded document had an incorrect name. This happened when the sender uploaded it using Icertis Experience for Outlook.
CS0162161	1714470	* RFQ remained stuck in the Awarding Initiated status even after the awarding was approved.
CS0161987	1714385	(For DocuSign only) When an agreement was sent for approval and external signature, it took a lot of time to change the status and remained in the Waiting for Internal Signature status.
CS0161603	1714726	Custom columns added in the saved search were removed while searching with keywords.
CS0161397	1713008	For an executed agreement, when you added an amendment and used the existing executed amendment (available under the same agreement) as a parent of the new amendment while selecting amendment template, the clause assembly didn't happen.
CS0159464	1708755	Remove and Replace User buttons weren't working for users when the agreement was in Terminated status.
CS0158684	1710699	Some attribute values weren't updated in a published amendment with associations.
CS0158092	1711800	(For Salesforce only) The Deviations tab for an agreement sometimes displayed multiple older deviations for the same clause that were no longer relevant.
CS0157973	1707856	When the language preference was set to a language other than English and you tried taking an action on commitments, the status options Cancelled , Failed , Postpone , and Succeeded were not translated and remained in English.
CS0157957	1708383	Default currency value wasn't selected for attributes having expressions.
CS0157598	1709222	Clicking the Upload button to upload a signed copy of a file resulted in an error.
CS0157534	1707763	When you uploaded the redlined document during approval process using document comparison functionality, the new document version reverted all redlined changes to the standard text.
CS0157454	1713405	The Lookup and Cascade options didn't work for terminated agreements.
CS0156874	1722814	* After the RFQ was approved, creating associations using the Create Association icon (+) didn't work. However, associations could be created using the drag-and-drop option.

CS0156800	1710139	Associative entity tables (bridge tables) were missing for self-linked contract types.
CS0156137	1702634	The values assigned to template variables during agreement creation were no longer visible when you edited the agreement.
CS0155182	1706531	(For Salesforce only) File upload dialog box did not appear, or file upload gave an error.
CS0154755	1703345	For Obligation entity, trying to add a secondary owner through role-action mapping for the Create Association From Parent and Create Association From Tile system actions resulted in an error.
CS0154175	1706603	(For Salesforce only) When you clicked the Manage button on the Association tab for an agreement in Salesforce, it resulted in an error. Also, if you tried going back to the previous window by clicking the Go Back button, you were redirected to the ICI home page instead of the previous window.
CS0154127	1699943	* You could not add custom columns in sourcing agreement validation.
CS0154098	1706612	(For Salesforce only) When you clicked the Manage button on the Association tab for an agreement in Salesforce, it redirected you to an incorrect association.
CS0153565	1705604	The Advanced Search functionality didn't work as expected if you selected Document Text from the Data Type dropdown.
CS0153309	1703349	When the paper type was Own while creating an amendment, the default value of the Use Amendment Template (ICMUseAmendmentTemplate) attribute was overwritten even when the attribute was set to Off in the contract type.
CS0151158	1695603	The question response template was downloaded twice and one of the files didn't have any data.
CS0148952	1736502	Approving or rejecting agreements from email failed at times. This happened because the hyperlink wasn't enabled in email.
CS0148823	1699273	* After sending a round for approval, the Evaluator Score attribute didn't reflect on the UI in Questions for an association of a sourcing RFx.
CS0147207	1694901	In ICI, a KPI from a saved search couldn't be created when the saved searches count was more than 1000.
CS0145471	1688814	When the language preference was set to a language other than English, the Action Taken By verbiage in the Additional Information column on the agreement Team tab remained in English instead of converting to its relevant language translation.

CS0137806	1679696	* ICMTemplateVersion is set to "0" when type of paper is Own and Enable Quick Creation is True.
CS0137406	1699863, 1682930	For any attribute with data type as Currency , there was an error while uploading the existing bulk association, post 8.2 upgrade with sourcing enabled.
CS0137186	1735138	* After you created and sent the RFQ for approval, and started the evaluation, the evaluator didn't get the notification for evaluation being started.
CS0135578	1678579	The Save Search column showed incorrect display name.
CS0130105	1677056	* (For DocuSign only) When you created, approved, and sent an agreement for signature, the agreement was stuck in the Approved status.
CS0113761	1670663	Some process execution errors occurred when the workflow was triggered for the API endpoint with asynchronous processing.
CS0103875	1671707	After upgrading to ICI 8.2, it took more time to view or edit rules.
