ICI 8.2 (Patch 3)

The Icertis Contract Intelligence (ICI) 8.2 (Patch 3) brings some bug fixes and updates.

Bugs fixed

The following bugs have been fixed in this patch (8.2.3.0):

Bug ID	Description
1578016	(Only for DocuSign) Sending an agreement for signature using DocuSign, an error occurred when the subject had more than 100 characters.
1580564	On updating an amendment, the expiry date was not updated as expected.
1582668	Executing Business API for searching amendments was fetching incorrect records.
1585114	Trying to navigate back from an agreement or association summary page resulted in an error.
1588336	Editing a user group resulted in an error.
1590155	When taking action on commitments, the reminder added in days was displayed as a single digit number instead of double digits.
1590381	When selecting Masterdata on the Configure tile, clicking View More and increasing the number of records to 100 resulted in an error.
1590575	When editing a contract type such as non-disclosure agreement, garbage values were displayed for most attributes.
1591314	After reloading a document that had track changes enabled, the entire document was shown as deleted.
1591315	On deleting text inside locked clause text, the Click or tap here to enter text message was displayed.
1592218	On uploading legacy information for multiple records, the uploaded data displayed incorrect information.
1592301	Users were unable to create agreements using the Copy Record option.

1592645	After adjusting the column width on the Advanced Search page, commitment filters did not work as expected.
1592662	The associations added to an agreement were displayed as inactive in the database.
1592720	Agreements created with special characters were not displayed in History under List view.
1593738	The Preview functionality was not working as expected when using Salesforce with Lightning UI.
1594809	The expand and collapse functionality did not work as expected for enabled team and clauses on the Chrome browser.
1597240	Processing records using the generic integration framework took longer than expected.
1597620	Editing an agreement to update an attribute resulted in an error.
1597812	Trying to add a user group in the team using Business API did not work as expected.
1597833	On performing SFDC forward synchronization, duplicate associations were created.
1597992	Trying to open an Expiring Agreements Report resulted in an error sometimes.
1598317	Logging in to Icertis Experience for Word and executing the ExecuteSavedSearchAPI resulted in an error.
1599131	Creating a clause assembly rule and performing P2P operation resulted in an error.
1600304	After changing the language preferences to Japanese, the linkage type was not translated correctly.
1600588	Creating an agreement and adding a table under Description resulted in an error.
1600755	 When users in an agreement team had different language preferences and performed one or both of the following actions, the user roles were not displayed in the expected language. Opened the agreement at the same time using different browsers Clicked the Team tab
1600846	On upgrading ICI, the home page widgets were not redirecting to the correct page and were displaying incorrect counts.
1601127	Updating the Business API for contract requests did not work as expected if the request included a "parent contract type" attribute.
1601566	Updating an agreement did not work as expected for some agreements with associations.

1601644	The UserResponseToDocumentValidationWarnings key was enabled in the Business API.
1602442	There were localization issues for notifications, user profile, bulk actions, and user role entities in ICI.
1602695	Updating an amendment using API resulted in an error.
1603249	Business Summary dashboard did not open on the first click.
1603331	After enabling the Enable Quick Creation option and publishing the agreement, there was no validation displayed.
1603545	Clicking the Search option for an attribute on Create Agreement page was displaying more records than expected.
1603791	Creating an approval rule resulted in a validation error.
1605092	 (Only for third-party paper) An exception sometimes occurs when: You publish an agreement by clicking Create & publish. You click Discover to discover agreement entities.
1605307	Clicking the Design Preview button in Icertis Experience for Word converted a non- editable clause to editable.
1609253	*On cancelling an RFx, its history was not updated correctly.
1609991	On creating an obligation, users were not displayed in its team.
1617687	Sending an agreement for external signature changed its status to Executed instead of Waiting for Signature .

Note: The asterisk (*) indicates a ported bug. These are bugs found and resolved in a version higher or lower than the current one, and its fix has been merged into this patch.
