ICI Release 8.2 (Patch 2)

Introduction

The Icertis Contract Intelligence 8.2 Release (Patch 2) offers some bug fixes.

Bugs Fixed

The following bugs have been fixed with this patch (8.2.2.0):

Bug ID	Description
1553786	When opening a notification subscription, clicking the view icon to open the link in the new tab was not working as expected.
1558784	Adding an external user was not working as expected, if the 'Is Authorized Signatory' flag was enabled or disabled.
1559069	Creating an agreement was resulting in an exception error.
1560719	Sending an agreement for electronic signature using Adobe Sign was not working as expected.
1560806	On creating an agreement, the value of the cascade attribute was not populating as expected.
1562034	When adding an amendment, the template was being displayed but was not selected automatically.
1562808	Pinning a saved search in Salesforce was not working as expected.
1562961	Parallel processing of procedures in Power BI was resulting in performance issues.
1566066	Contract requests disassociated from agreements continued to reflect in the associations of the contract request.
1566576	Sending an agreement for approval after applying approval rule was not working as expected.
1567061	Updating an agreement by updating the user attribute was not working intermittently.
1567175	The text area was not being displayed as expected on the agreement Details page.
1567780	When creating a contract request, the contract type description was not being displayed.
1568264	When creating an agreement, the conditional attributes were being displayed even after hiding them.
1568993	On filtering records for a specific entity on the agreement management index page, blank records were being displayed.
1569092	On upgrading ICI to Version 8.2, sending an agreement for electronic signature was not working as expected.





1570184	Applying filters for choice attributes configured for agreement or masterdata contract types was not working as expected.
1570683	Users were being logged out of ICI intermittently.
1571052	Agreements were not being displayed as expected after converting it to PDF.
1573705	Deviations were not being displayed in the right column, if viewing them from SFDC.
1574279	The Approve and Reject buttons were not being enabled automatically after selecting one or more associations.
1575990	The IP security was not working as expected for some electronic signature workflows.
1576889	On creating a new user through Postman using SCIM API, the newly created user was not being displayed on service bus.
1579769	Trying to view rule information was resulting in a correlation ID error.
1580944	Discovery was not working as expected for documents in French.
1581410	Inheriting the line item was not working as expected.
1581565	On executing an agreement and downloading the PDF, the content appeared misaligned.
1582025	On publishing an agreement, there was a discrepancy between the dynamic attribute values displayed on the Summary and Details pages.
